

## **Radiant Credit Union Outdoor Adventure Prize Pack Contest Rules**

### **Official Promotion Rules**

1. **Eligibility for Promotion:** All Radiant Credit Union ("Radiant") Members in good standing who submit an official entry after visiting Radiant Credit Union's Old Town branch location between August 30, 2023, and September 29, 2023. Participation is limited to eligible persons who are 18 years or older and U.S. residents. By submitting an entry you agree to be bound by these Official Rules. No purchase necessary.
2. **Promotion Period:** The Promotion period begins on August 30, 2023, and ends on September 29, 2023, and applies to entries received by Radiant during this period. Employees of Radiant, members of the Board of Directors and the immediate family members of each residing in the same household are not eligible. Winners will be notified by Radiant using contact information provided in entry. If the prize is unclaimed, an alternate winner will be chosen.
3. **Prize:** Radiant will award an "Outdoor Adventure Prize Pack" consisting of the following: a cooler, two bag chairs, two insulated cups, two cooling towels, and other assorted items. The prize value is \$300.00. The odds of winning will depend upon the number of entries, which may be substantial, and Radiant makes no assurances about an individual's chance of receiving the prize. Radiant may substitute the prize elements for those of an equal value.
4. **Manual Entries:** No purchase necessary. For entries not using the provided QR code and online form, individuals must submit a written entry on a 3 x 5 piece of paper setting forth the entrant's name, address, telephone number, and account number/member number if applicable. One entry per envelope for manual entries; no photocopied or mechanically reproduced entries accepted; and Radiant is not responsible for lost, late, misdelivered, incomplete, or postage-due entries. Only one manual entry will be accepted per person and/or household.
5. **Prize Claim:** To claim the prize, the must sign and return a release and an affidavit of eligibility and publicity release to Radiant Credit Union at Attn: Marketing - Outdoor, 4440 NW 25th Place, Gainesville, FL, 32606, within 14 days of notification, or prizes will, at Radiant's discretion, be forfeited. The prize will be awarded only if entrants comply with these Official Rules. No cash or other consideration will be paid.
6. **Agreement:** You agree that entry into the Promotion did not induce you to become a member of Radiant or obtain any services with Radiant during the Promotion period.
